## Preparing for your Viva

School students are expected to sit a mock viva conducted by their MPhil/PhD panel before the submission of the final thesis. This is designed to provide the student with practical experience in a

viva setting, and an opportunity for advice and feedback from the panel in advance of final submission. The mock viva is organised by the supervisor(s).

Students will be expected to send their thesis to their panel at least three months before their submission date. A mock viva will be held four weeks after the submission of the draft thesis. The main reason for this requirement is to provide you with robust and critical feedback on your thesis in advance of your final submission, and to allow you to improve and correct any weaknesses which may be apparent in your work. This feedback should enable you to submit a stronger thesis and greatly improve your chances in the viva.

For those of you submitting this academic year, please factor this into your work schedule. It will be important that you submit your draft to your panel in good time, in order for the panel to have the time to read and comment on your work. For example, for those of you submitting in September, you will need to send your draft thesis May in order to have the mock viva in June and leave you sufficient time over the summer to refine your work.
