## STAFF AND STUDENTS

**A**lison MacLeod successfully defended her PhD thesis on 23rd February, with minor corrections. The examination was held at the HQ of the Geological Society in Piccadilly; the external examiners were Professor David Smith (Oxford University) and Professor Jaap van der Meer (QMUL), who commented that the thesis was one of the best they had ever examined, in terms of the quality of the science it reported. Her PhD was the product of a Tied NERC PhD Studentship, an important component of the recently-completed NERC-RAPID project.

**Marije Geldof** successfully defended her doctoral thesis entitled "Literacy and ICT: social construction in the lives of low-literate youth in Ethiopia and Malawi" on 5th February 2010. Her distinguished examiners were Rose Luckin (Professor of Learner Centred Design at the London Knowledge Lab, Institute of Education, University of London) and Dan Wagner (Professor of Education and Director of the National Center on Adult Literacy/International Literacy Institute, University of Pennsylvania), who required no revisions to the thesis.

## OUTSIDE ENGAGEMENTS

**David Simon** presented a research seminar to DPhil students at the School of Geography and the Environment, University of Oxford on 2 February on the subject of 'The challenge of global environmental change - research and policy advocacy'.

**Dr Vandana Desai**, was an invited panel member last week on 18th Feb 2010 at a round table discussion at the House of Lords, hosted by Baroness Sandip Verma, Shadow Minister for Children, Schools and Families. The debate explored new ways of fighting and alleviating poverty. Chaired by Professor Syed Ferhat Anwar of the University of Dhaka, panel members along with Dr Desai included Sir Fazle Hasan Abed, who received a Knighthood last week for his outstanding contributions to social improvement, poverty alleviation, and empowerment of the poor in Bangladesh (BRAC) and overseas; Professor Robert Chambers of the Institute of Development, University of Sussex; Professor Mushtaq Khan, School of Oriental and African Studies, University of London; and Peter Fowler, the ex High Commissioner to Bangladesh. Dr Desai concentrated on her research areas of urban poverty in the Indian sub-continent, particularly focusing on housing the poor, ageing, gender and NGOs. The panel aimed to raise the level of debate and of awareness of issues in provision of aid to Bangladesh and to address emerging issues in the context of economic growth in South Asia.

## GRANTS AND AWARDS

**Scott Elias** has been awarded a small grant of \$4,349 from the National Park Service of the USA. The project is entitled 'Paleoenvironmental Reconstruction of the Little Takli Island Peat Record.' Little Takli Island This is an island near Katmai National Park in southern Alaska. A coastal bluff on the island has an exposure of Holocene peat, associated with local archaeology. The aim of the project is to reconstruct the local climate and vegetation cover since the end of the last glaciation, through the analysis of insect fossils extracted from the peat. Scott will fly to the site next summer to take samples that will be shipped back to London for insect fossil analysis.

January 2010 - **Thomas Stevens** has been awarded a NERC FSF (NERC Field Spectroscopy Facility) ASD fieldpro probe loan in order to study the spectral reflectance properties of loess - £1980 equivalent. The equipment and operator visited the department in February 2010 and was used on archived samples of loess from the northwest of the Loess Plateau. Certain reflectance absorption features may be tied to mineral/clay mineral contents in loess and so may function as palaeoclimate proxies.
