A belated welcome to **Blaise Dupuis** who is a visiting PhD student being supervised by **Tim Cresswell** for 9 months. He is visiting from the University of Neuchatel in Switzerland and conducting research on the global mobility of ideas surrounding neo-traditional town planning.

Congratulations to **Thomas Barton** who has been awarded his PhD. The title of his thesis was 'Music, place, and the creation of cultural memory: a study of Benjamin Britten's War Requiem, John Adams' On the Transmigration of Souls, and Steve Reich's Different Trains'. It's a fine piece of work that pulls together ideas about music, memory/memorialisation, place and social trauma - highly ambitious and distinctive for a geographer, particularly in the way that it deals with technical composition of music as well as its social and cultural context. The thesis centres on case studies of three pieces of modern classical music: Benjamin Britten's War Requiem and its relationship with Coventry Cathedral; John Adams's The Transmigration of Souls and the public memory and memorialisation of 9/11; and Steve Reich's Different Trains and the commemoration of the Holocaust. The examiners were George Revill of the Geography Department at the Open University and Daniel Grimley of the Music Department and Merton College, Oxford University. Thank you to **Karen Till** for her work on Tom's Masters thesis that drew him toward this topic, and her contribution towards securing his ESRC studentship and to **Felix Driver** for his work as advisor on the project after Karen. His supervisor was **David Gilbert**.

## OUTSIDE ENGAGEMENTS

**David Simon** presented the opening session of the LSE Development Studies Institute's annual MSc retreat at Cumberland Lodge on 5 January on the theme of 'Tackling Climate Change: are the solutions part of the problem?' David introduced the theme and focused on the particular challenges in African contexts.

**David Simon** visited the Postcolonial Research Group at Newcastle University on 17th February to present a seminar on 'To and through the UK: Holocaust refugee ethnographies of escape, education, internment and careers in development.'

**Tim Unwin** gave one of the three presentations at the Public Chairs' Forum seminar on "How to be a great Chair in the Public Sector" held at the Institute for Government on 10th January 2011.

**Leonhardt van Efferink** gave a four-hour lecture-workshop at Maastricht University. He discussed with 40 students alternative ways to conceptualise, analyse and model country risk.

**Amanda Rogers** co-organised an event on Geography and the New Empirics on 20-21 January on behalf of the RGS Social and Cultural Geography Research Group. Held at UCL and the RGS, the event address the changing nature of the empirical in terms of new forms of data (such as the emotional and the affective), the new scales and quantity of data that Geographers deal with, and the practical/ethical issues of communicating this data to publics beyond the academy. Following workshop discussions and activities on the first day (Amanda organised and led one on Experimental Encounters), day two comprised a series of paper presentations. The event's themes were drawn together and expanded on through a keynote address by Alan Latham (UCL) and a final panel discussion with Ben Anderson (Durham), David Demeritt (King's), Malcolm

Fairbrother (Bristol) and Celia Lury (Goldsmiths). The event was a great success attracting around 50 participants from Geography, Sociology, Anthropology and Art.

**Duncan Depledge** delivered a presentation entitled 'The role of the UK in EU-Arctic relations. An honest broker?' at the British Library on 15th February as part of the third seminar in the ESRC Seminar Series titled 'Knowledges, Resources and Legal Regimes: The New Geopolitics of the Polar Regions' (<http://polargeopolitics.wordpress.com/>).

## GRANTS AND AWARDS

**Klaus Dodds** was awarded a £5000 grant by the British Academy/ACU Grants for International Collaboration for a project entitled 'Canada and the contemporary Arctic: action, anticipation and anxiety' which will involve collaborative work with the University of Alberta's Canadian Circumpolar Institute and Professor Mark Nutall in particular.

**Thomas Stevens** has been awarded a NERC joint standard grant as lead PI on 'Dust storms and Chinese loess sources over the last 22 Myr'. The project aims to constrain the sources of dust that form the largest and longest-lived dust sequences in the Cenozoic record, using a variety of geochronological and geochemical analyses on single heavy mineral grains. The project co-PIs are Pieter Vermeesch (Birkbeck, Earth Sciences) and Randy Parrish (British Geological Survey/NERC Isotope Geosciences Laboratory) and involves support from Project Partners in Nanjing, China (Lu Huayu) and Aberdeen (Peter Clift). The total RHUL RC contribution is £328,675.

**Mustafa Dikeç** has been successful with an AHRC application on 'Pumping Time: Geographies of temporal infrastructure in fin-de-siècle Paris' to the value of £165,101.

**Dorothea Kleine** has obtained £12k from The Body Shop as its contribution to a planned ESRC CASE doctoral studentship starting this coming autumn.

**Simon Armitage** has been successful in a grant application as part of a major 5-year European Research Council project based at Bergen University, with the evocative acronym TRACSYMBOLS. The full title is 'Tracing the evolution of symbolically mediated behaviours within variable environments in Europe and southern Africa'. Research has already commenced but the formalities have only just been finalised. Simon's component is worth €30k (£25.5k).

**Sara Fregonese** has been awarded from the British Academy Small Grant (£ 7301, 24 months, starting May 2011) titled "Views from the Holiday Inn: landscape, war and memory in Beirut". The project aims at creating a digital archive of the collective memory of the hotel Holiday Inn, a building crucial for the physical division of Beirut during the Lebanese civil war. The project is inserted in a series of other debates and initiatives that counteract Lebanon's state-led amnesia since a generally amnesty was granted at the end of the war in 1991.
