After graduating with a degree in Economics, I then went on to do a master's in international development at the University of Manchester. Some way through my postgraduate degree, I took up a Prospect Research role at Christian Aid; the organisation aims to work with communities around the world to end global poverty and here I was essentially researching funding. I started out as a part-time researcher and ended up being senior researcher effectively managing the team. After a couple of years there, I then moved to my current role at HMRC as an Economist. I work within the Economic Projects team in Personal Taxes. My role and team are quite project based and wide-ranging often working with multiple stakeholders to complete different types of analysis (e.g. evaluations, costings) on savings, pensions and reliefs.

Top Tips

- Work hard and play hard in both, be disciplined.
- Be tactical a role may not be what you exactly want but get your foot in the door (of the sector of interest) and use it as a stepping stone.
- No job is too big for you just throw your hat in the ring. Take a chance and someone may take a chance on you.

On my desk we manage c.£900m with the desk operating on a discretionary managed portfolio service. The areas I cover are portfolio management, investment management, equity research/ collective fund management and management of the strategic/ tactical asset allocation of the desks risk strategies. I currently hold a BSc in Economics, IMC from CFA UK and the IAD from the CISI.

Top Tips

- Set up your linked in pages to a high standard and use the app for your digital career reflection and job hunting. Use it to see job listings and what type of jobs are out there, and what type of companies are hiring.
- Create a multifaceted CV, which showcases sport, extracurricular and interests of yours, in addition to concise experience and educational areas. Employers want key words to stick out (highlight them in blue for example).
- In order to work In investment management/ asset management, make sure your nonverbal, numerical and verbal reasoning is to a high standard. All jobs will have tests and assessment centres. Do practice papers. If you want to break into industry, and want to look above other students, start/complete your level 4 RDR compliant financial studies (Investment Management Certificate or Investment Advice Diploma). This will make you look more serious.
